  recommendations or nominations to Regional Council respecting the
  appointments to various Boards, Committees and Commissions
- a. by the Executive Standing Committee under section 4 of Schedule 6 Executive Standing Committee Term of Reference, and
- b. by the remaining Standing Committees, as outlined in Attachment 1 of the staff report dated November 8, 2024;
- 2. Appoint the Members of Council to Boards, Committees and Commissions for a term to November 2026, as outlined in Attachment 2 of the staff report dated November 8, 2024;
- 3. Appoint the Members of Council, who are the successful candidates after receiving the most votes after a vote by secret ballot, to the various Boards, Committees and Commissions as outlined in Attachment 3 of the staff report dated November 8, 2024, for the following terms:
- a. a term to November 2026, except for two appointments to Halifax Water Board of Commissioners, and
- b. for two Members of Council appointed to the Halifax Water Board of Commissioners, for terms to November 2027.

### 15.1.4 Deferral of Deputy Mayor Appointment Motion:

That Halifax Regional Council:

- 1. Suspend the rule of procedure in Administrative Order One, the Procedures of the Council Administrative Order, requiring the election of a Deputy Minister in November annually;
- 2. Extend the term of Councillor Cathy Deagle Gammon as Deputy Mayor until the later of December10, 2024, or a new Deputy Mayor is elected by Regional Council; and
- 3. Defer the appointment of the Deputy Mayor to the December 10, 2024, meeting of Regional Council.

### 15.2.1 Councillor Austin – Affordable Housing Tax Relief Motion:

That Halifax Regional Council direct the Chief Administrative Officer to prepare a staff report on increasing HRM's tax relief for non-profits that provide affordable housing beyond the 50% grant that HRM current provides to as much as 100%.

### 15.2.2 Councillor Young – Beaver Bank Cross Road Traffic Light Installation Motion:

That Halifax Regional Council direct the Chief Administrative Officer to prepare a staff report on the potential of a traffic light at the Beaver Bank Cross Road and Sackville Drive to alleviate traffic congestion and allow for positive traffic flow in the area that will also coordinate with the Millwood Drive traffic light.

### 15.2.3 Councillor Young – Hammonds Plains Road Traffic Congestion Motion:

That Halifax Regional Council direct the Chief Administrative Officer to prepare a staff report on the potential to widen Hammond Plains Road where applicable from Westwood Drive to the Bedford Highway to include a reversible third lane, multi-use pathway, designated park and rides, express transit buses direct to highway non-stop to downtown Halifax.

# 15.2.4 Councillor Young – Halifax Transit to consider a connector bus from Lucasville Road to Timber Trails to the Sackville Terminal Motion:

That Halifax Regional Council direct the Chief Administrative Officer to prepare a staff report and presentation to Halifax Transit to consider a connector bus from Lucasville Road to Timber Trails Trailer Park to the Sackville Terminal. The report should include data on the vehicle daily traffic numbers- with peak period during the day- Monday to Friday and Saturday to Sunday on the Lucasville Road, potential transit stops, potential cross walk locations, potential size of the community transit terminal at the Timber Trails Trailer Park, potential size of the community transit terminal (park and ride) at the Timber Trails Trailer Park, potential hourly schedule times for the connector bus on this proposed transit route, a future community engagement for this potential connector bus route, any potential land acquisition, any potential infrastructure planning prior to project implementation which would include the residents of Lucasville.

### 15.2.5 Councillor Young – Avebury Court Middle Sackville - Designated Greenspace Motion:

That Halifax Regional Council direct the Chief Administrative Officer to prepare a staff report on if a Designated Greenspace exist for a section of Avebury Court in Middle Sackville.

That Halifax Regional Council direct the Chief Administrative Officer to follow up if a staff report was previously done on the Lakeview Avenue Sidewalk Plans. If so, what is the status of those plans. If not, please prepare a staff report on the potential for sidewalks on Lakeview Avenue.
