SUBJECT: 2026 Halifax Regional Council Meeting Schedule

ORIGIN

Halifax Regional Council must adopt a schedule for meetings of Regional Council for the upcoming year.

EXECUTIVE SUMMARY

An annual schedule for each meeting body is adopted each fall for the upcoming calendar year.

RECOMMENDATION

It is recommended that Executive Standing Committee recommend that Halifax Regional Council adopt the proposed 2026 Regional Council meeting schedule as outlined in Attachment 1 of this report.

BACKGROUND

In accordance with Administrative Order One, Section 8, regular Council sessions are held on those Tuesdays determined by Council at an hour deemed appropriate by the Mayor and Chief Administrative Officer (CAO) jointly. Regularly scheduled meetings of Council may be cancelled with the agreement of the Mayor and CAO. Other meetings of Council may be added with appropriate notice provided it is done in accordance with the Halifax Regional Municipality Charter and Administrative Order One.

DISCUSSION

Since amalgamation Regional Council has adopted a meeting schedule for the coming year. This process allows members of Council, staff and the public to be notified and plan for Council meetings.

Since 2014, Council has met bi-weekly. The attached proposed modified bi-weekly schedule proposes 22 regular meetings and 1 if required meeting. The proposed schedule considers statutory holidays, March Break, Federation of Canadian Municipalities' Annual Conference, Nova Scotia Federation of Municipalities' Fall Conference, the proposed 2026 Budget Committee schedule and the number of meetings provided for in 2025.

FINANCIAL IMPLICATIONS

No financial implications at this time.

RISK CONSIDERATION

A delay in approval could result in additional delays for other meeting schedules, as consideration of the approved Council schedule is used when proposing other Committee meeting dates.

COMMUNITY ENGAGEMENT

No community engagement was required.

ENVIRONMENTAL IMPLICATIONS

No environmental implications were identified.

ALTERNATIVES

Amendments to the proposed Regional Council meeting schedule as outlined in Attachment 1 may be made as required.

LEGISLATIVE AUTHORITY

Administrative Order 1, the *Procedures of the Council Administrative Order* (Administrative Order One), subsection 4(2), and section 8, as follows:

4 (2) Notwithstanding subsection (1), any one or more of the rules of procedures contained herein except for sections 5 and 41 and subsections 12(5) and 59(3) may be suspended by Council, Committee of the Whole, Community Council or a Standing Committee by the affirmative vote of two-thirds (2/3rds) of the Members present and voting

8. The Council shall meet on such Tuesdays determined by Council, and shall be held at such an hour as deemed appropriate by the Mayor and CAO jointly.

Administrative Order One, Schedule 6, Executive Standing Committee - Terms of Reference

8. The Executive Standing Committee shall act as a review committee for matters related to the general self-governance and administration of the Council as directed by the Council.
