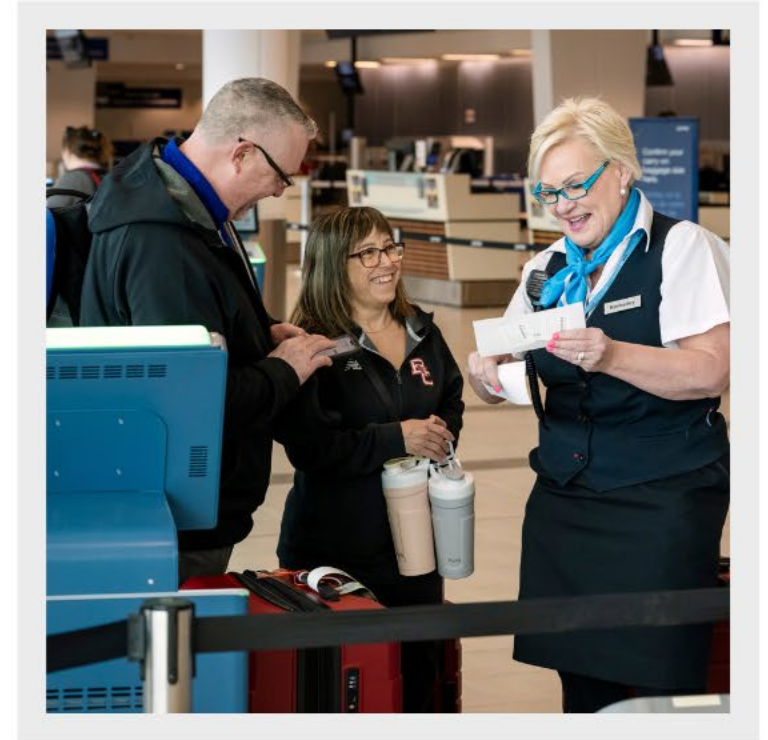

- Total employment (FTE) of 18,941





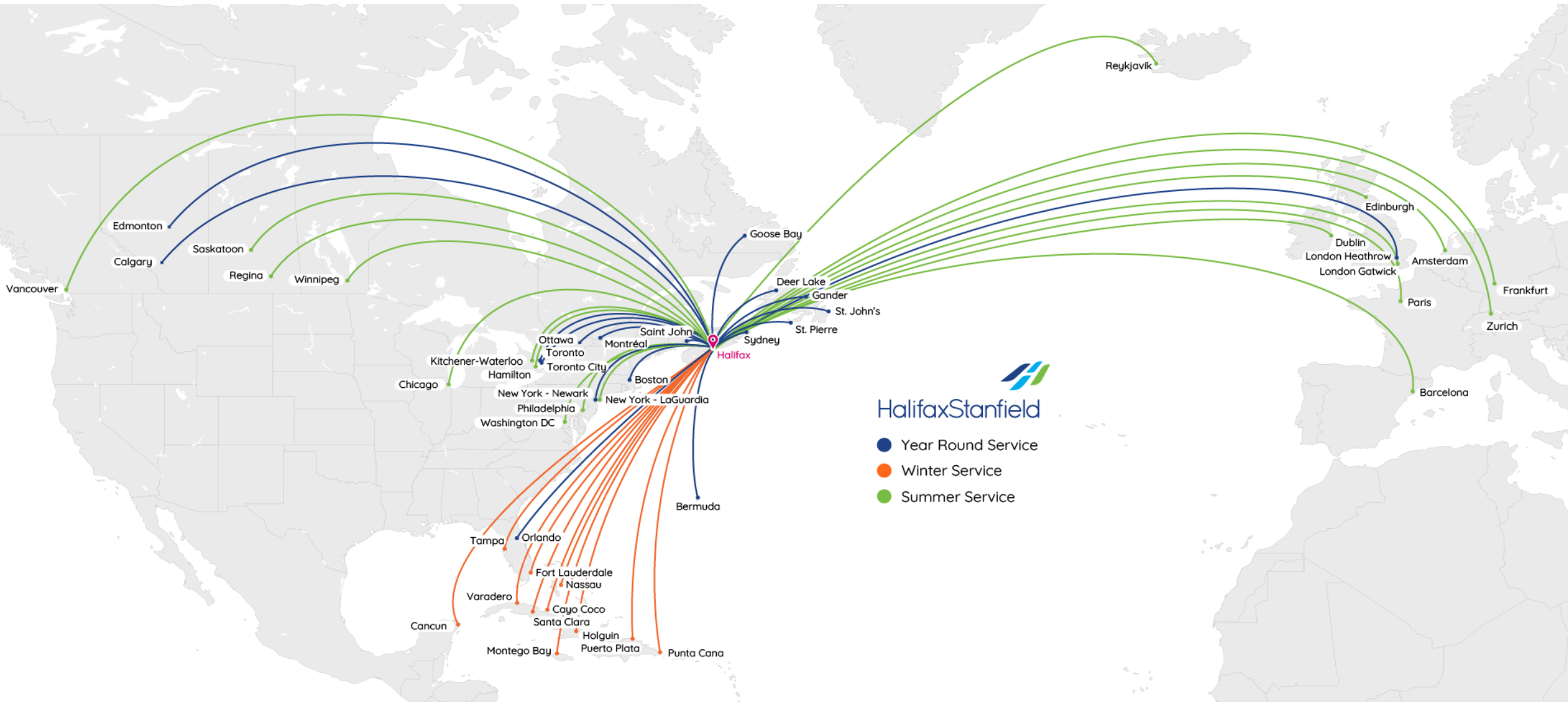

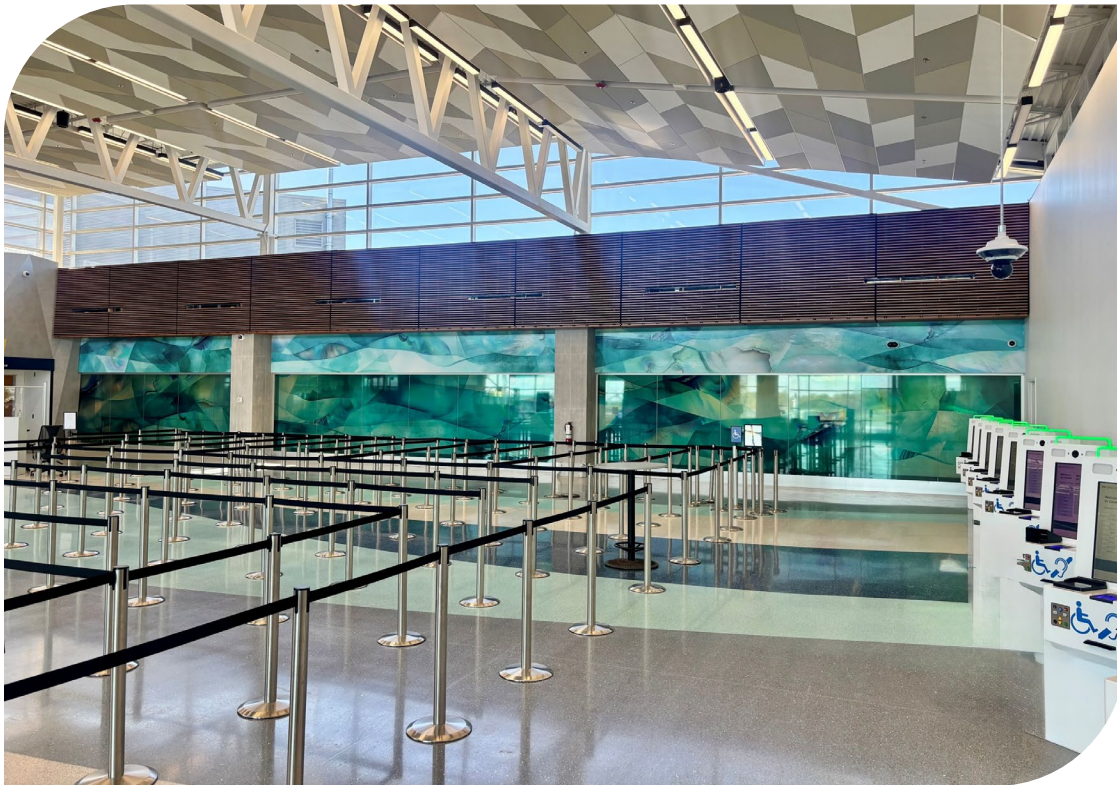
